Independent Facilitator for GTAC workshops

As notified in our 17 August News Bulletin, Gas Industry Co has appointed Mike Underhill as the Independent Facilitator (IF) for the GTAC workshops from 1 September 2018.

Following a concern raised by a stakeholder regarding Mike's position as a director of Electra Limited and Electra Generation Limited, we provided stakeholders with an opportunity to comment on two possible options:

1. Mike Underhill continues in the role as IF for the remaining workshops with stakeholders noting the interest mentioned above.

2. Gas Industry Co looks for a replacement IF, in which case the workshops scheduled for early September will continue without an IF.

With the exception of one stakeholder, submitters preferred option one. Having considered submitters' comments, Gas Industry Co has decided to continue with Mike's appointment as the IF for the remaining workshops.
